## **Admissions Policy**

## Introduction

It is our intention to make our setting accessible to children and families from all sections of the local community. We aim to ensure that all sections of our community have access to the setting through open, fair and clearly communicated procedures.

## Admissions Procedures

We ensure that the existence of our setting is widely advertised in places accessible to all sections of the community. We ensure that information about our setting is accessible, in written and spoken form and, where appropriate and in more than one language when requested.

We currently have one in-take a year, in September. We do accept occasional admissions during the academic year if we have spaces available. We arrange our waiting list in birth order as advised by LEA guidelines. In addition, our Policy will take into account the following:

- Siblings already attending the Primary School;
- Children who are referred to us by the Children's Centre;
- Children who are eligible for vulnerable twos funding;

Our setting is open from 8.45am - 2.45pm. We offer flexibility in sessions which can be morning or afternoon sessions (3 hours duration) or full day sessions (6 hours duration.)

There is no maximum limit on the amount of hours a child can attend and sessions can be funded by the Government and/or paid for at a rate of £14 per 3 hour session. This ensures that the child has continuation of childcare provision. In order to promote this, we will not take children for less than 3 sessions (9 hours) a week.

We keep a place vacant, if this is financially viable, to accommodate an emergency admission.

We describe our setting and our practices in terms that make it clear that we welcome parents, relations and other carers, including childminders.
